I. INTRODUCTION (1 of 2):





The second WinG meeting under the ROWER project was held in Sandanski, on 15-17 April, 2010. The workshop focused on the Macroeconomics of Occupational Health and Safety with reference to various factors at the national and social level. A particular objective of this workshop was to analyze and estimate the impact of regulation, changes in labour force structure and changes in economy on the occupational health and safety.

I. INTRODUCTION (2 of 2):

Special emphasis was put on the problems of measurement of the economic impact of occupational accidents and diseases at national level and problems of cost internalizations. Besides the ROWER partners, the workshop attracted prominent experts in the scope of occupational health and safety from the USA, Canada, Germany, Austria, Poland, who contributed their knowledge and expertise.

II. Meeting Location:



The meeting was held in the Park-hotel Pirin, Sandanski, Bulgaria. The hotel offered excellent accommodation and perfect work environment. The town of **Sandanski** is situated to the southwest of the capital Sofia and to the south of the regional center of Blagoevgrad, not far away from the border with Greece.

III. OBJECTIVES:

As initially planned by ROWER project (in the proposal stage) the main objectives of this workshop were to analyze and estimate the impact of regulation, changes in labour force structure and changes in economy on the occupational health and safety. Special emphasis was put on the problems of measurement economic impact of occupational accidents and diseases at national level and problems of cost internalizations.

VI. TOPICS (1 of 4):

As initially planned by ROWER project the general directions of research were:

- •Impact of changes in labour force structure (ageing, increase of female employment, etc.) and relation to quality of employment.
- •Impact of changes in economy (shifting to less labour-intense sectors, international competition, new forms of employment, etc.)
- •Measuring economic impact of occupational accidents and diseases in national level (agreement of common principles for measuring costs).
- •Impact of regulation (legislation, insurance systems, equal opportunities, etc.)
- Cost internalisation (the case of the State)

- Is the incidence (future costs of accidents and diseases occurring during the reference year) or prevalence approach (costs of accidence at the reference year regardless to when they occurred) more fit for measuring cost at national level?
- Are the traditional accounting tools proper for measuring OHS cost?

- Which economic parameters affect OHS and how?
- How will the current recession affect OHS?
- Should fatal or total accidents be examined in studies?
